PRESIDENT'S CERTIFICATE OF MERIT AWARD

CENTRAL POSTER AWARD

1. The Central Association of Obstetricians and Gynecologists offers annual **cash awards for outstanding investigative or clinical work in the field of Obstetrics and Gynecology.**
2. Those eligible to compete are accredited physicians, teachers, research workers, and medical students whose work was done either within the geographic area of the Association (Alabama, Arizona, Arkansas, Colorado, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, Utah, West Virginia, Wisconsin, and Wyoming) or outside the geographic area of the Association if directly supervised by an active CAOG member.
3. **Abstracts must be original, not having been previously presented, submitted, accepted, or published.** Abstracts will be considered for both the general program and the awards unless the author specifically requests otherwise in writing.
4. For consideration for these awards an on-line abstract must be submitted to the CAOG Scientific Program Committee no later than the designated date. The abstract should show the authors with their appropriate titles and medical institutions as they would appear on the published paper. At least one of the authors must be a member of The Central Association of Obstetricians and Gynecologists. If the abstract is accepted for oral presentation, the author must submit a full-length original manuscript that complies with peer reviewed medical journal guidelines to the CAOG Program Committee.
5. **The Annual Central Prize Award of \$2,000, the President's Certificate of Merit Award of \$1,500, and at least two Central Poster Awards of \$500 each** will be presented to the successful author(s) at the Annual Meeting of the Association. These papers shall be presented as part of the Scientific Program at the Annual Meeting. The papers will be offered for publication to a peer reviewed medical journal acceptable to the CAOG Board of Directors.

2. Those eligible to compete are residents, fellows, medical students, and new practitioners (less than three years) whose work was done either within the geographic area of the Association (Alabama, Arizona, Arkansas, Colorado, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, Utah, West Virginia, Wisconsin, and Wyoming) or outside the geographic area of the Association if directly supervised by an active CAOG member.
3. This award is given to encourage residents, fellows, medical students, and new practitioners to become involved in the Central Association. At least one of the authors of the abstract submitted must be a member of the Central Association.
4. **Abstracts must be original, not having been previously presented, submitted, accepted, or published.** Abstracts will be considered for both the general program and the awards unless the author specifically requests otherwise in writing.
5. For consideration for these awards an on-line abstract must be submitted to the CAOG Scientific Program Committee no later than the designated date. The abstract should show the authors with their appropriate titles and medical institutions as they would appear on the published paper. At least one of the authors must be a member of The Central Association of Obstetricians and Gynecologists. If the abstract is accepted for oral presentation, the author must submit a full-length original manuscript that complies with peer reviewed medical journal guidelines to the CAOG Program Committee.

1. The Central Association of Obstetricians and Gynecologists offers an annual award of **\$1,000** for clinical study or research in the field of Obstetrics and Gynecology to members located in community hospitals who are not full-time medical schools.
2. Those eligible to compete are residents, fellows, medical students, and new practitioners (less than three years) whose work was done either within the geographic area of the Association (Alabama, Arizona, Arkansas, Colorado, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, Utah, West Virginia, Wisconsin, and Wyoming) or outside the geographic area of the Association if directly supervised by an active CAOG member.
3. This award is given to encourage participation in the scientific proceedings of the Central Association by physicians who practice in community hospitals. At least one of the authors of the manuscript submitted must be a member of the Central Association. Preference for this award will be given to papers concerning diagnostic or therapeutic procedures which enhance the quality of care of gynecologic or obstetric patients.
4. **Abstracts must be original, not having been previously presented, submitted, accepted, or published.** Abstracts will be considered for both the general program and the awards unless the author specifically requests otherwise in writing.
5. For consideration for these awards an on-line abstract must be submitted to the CAOG Scientific Program Committee no later than the designated date. The abstract should show the authors with their appropriate titles and medical institutions as they would appear on the published paper. At least one of the authors must be a member of The Central Association of Obstetricians and Gynecologists. 2. Those eligible to compete are residents, fellows, medical students, and new practitioners (less than three years) whose work was done either within the geographic area of the Association (Alabama, Arizona, Arkansas, Colorado, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, Utah, West Virginia, Wisconsin, and Wyoming) or outside the geographic area of the Association if directly supervised by an active CAOG member.
